# ARTICLES OF INCORPORATION

OF

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE ONE

The name of the corporation is: WATERTIGHT CONCRETE

RESTORATION, INC. The principle address of the corporation is: 738

### ARTICLE TWO

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.
