The undersigned, acting as incorporator(s) of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


**ARTICLE XI**

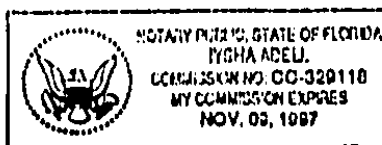
