ARTICLES OF INCORPORATION OF MILL CREEK SOD. INC.

ARTICLE I. NAME AND PRINCIPAL ADDRESS

The name of this corporation is MILL CREEK SOD, INC.. The principal address of the corporation is 4699 N. Canoe Creek Road, Kenansville, Florida 34739.

ARTICLE II. COMMENCEMENT OF EXISTENCE

This corporation shall begin its existence on the 1st day of May, 1995.

ARTICLE III. DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV . PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.
