ARTICLES OF INCORPORATION
OF

TRINITY 1 OF PASCO, INC.

ARTICLE 1: NAME AND ADDRESS

The name of this Corporation is : TRINITY 1 OF PASCO, INC. and the address is: 10505 Kitten Trail, Hudson, FL 34667 (Mailing P.O. Box 5021, Hudson, FL 34674)

ARTICLE 2: DURATION

This Corporation shall exist perpetually. In accordance with Section 607.0203, the corporation effective date requested is the later of five (5) business days prior to the date of filing or May 1, 1995.

ARTICLE 3: PURPOSE


ARTICLE 10: INDEMNIFICATION
