ARTICLES OF INCORPORATION

OF

CERTIFIED ENTERPRISE SERVICES INVESTMENTS, INC.

The undersigned, desiring to organize a corporation under Chapter 607, Florida Statutes, sets forth the following:

ARTICLE I

The name of the corporation shall be Certified Enterprise Services Investments, Inc.. The address of the principal office of the corporation and the mailing address of the corporation is 1771 Edgewood Avenue West, Jacksonville, Florida 32208.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLL III
