AMENDMENT TO ARTICLES OF INCORPORATION

GULF ATLANTIC MANAGEMENT CORPORATION

WHEREAS, the Articles of Incorporation of GULF ATLANTIC MANAGEMENT CORPORATION were filed with and approved by the Secretary of State of the State of Florida on the 4th of May, 1995; and

WHEREAS, it is the intention of all of the directors and all of the stockholders of GULF ATLANTIC MANAGEMENT CORPORATION that the Articles of Incorporation of GULF ATLANTIC MANAGEMENT CORPORATION be amended in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment was approved and adopted by all of the directors of GULF ATLANTIC MANAGEMENT CORPORATION, pursuant to the provisions of Florida Statutes, Section 607.0821, on the 28th day of July, 1999; and

WHEREAS, the proposed amendment was approved and adopted by all of the stockholders comprising the only voting group of stockholders of GULF ATLANTIC MANAGEMENT CORPORATION, pursuant to the provisions of Florida Statutes, Section 607.0704, on the 28th day of July, 1999; and

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment hereinafter set forth is hereby requested.

NOW, THEREFORE, the Articles of Incorporation of GULF ATLANTIC MANAGEMENT CORPORATION are hereby amended, by deleting in its

entirety the present Article 4 and by substituting therefor the following, to-wit:

"ARTICLE 4: MANAGEMENT STOCK: This Corporation is authorized to issue One Million (1,000,000) shares of common stock, having a par value of One Dollar (\$1.00) per share."

NOW, THEREFORE, the Articles of Incorporation of GULF ATLANTIC MANAGEMENT CORPORATION are hereby further amended, by deleting in its entirety the present Article 6 and by substituting therefor the following, to-wit:

"ARTICLE 6: <u>BOARD OF DIRECTORS</u>: The number of directors of the corporation shall be not less than one (1), nor more than fifteen (15)."
