ARTICLES OF INCORPORATION
OF
GULF WEST INVESTMENT CORPORATION

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

ARTICLE 1: NAME. The name of this Corporation is:
Gulf West Investment Corporation

ARTICLE 2: DURATION: The term of existence of the Corporation is perpetual.

ARTICLE 3: PURPOSE: This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE 4: CAPITAL STOCK: This Corporation is authorized to issue One Million (1,000,000) shares of common stock, having a par value of One Dollar (\$1.00) per share and Two Hundred Thousand (200,000) shares of non-voting preferred shares, having a par value of Two Dollars and Fifty Cents (\$2.50) per preferred share.

ARTICLE 5: INITIAL REGISTERED OFFICE AND AGENT:

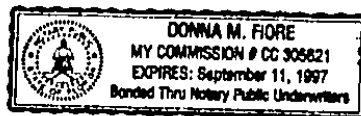
