

ARTICLES OF INCORPORATION OF SUCCESS KIDZ, INC.

ARTICLE I

The name of this corporation shall be:

SUCCESS KIDZ, INC.

ARTICLE II DURATION

This corporation shall commence its existence on the date of filing of these Articles of Incorporation, and shall exist perpetually unless sooner dissolved according to law.
