ARTICLES OF INCORPORATION
OF

ARTICLE I.

The name of this Corporation is:

South Florida Kinetics, Inc., a Florida corporation.

ARTICLE II.

This Corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE III.

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV.

This Corporation is authorized to issue 1,000 shares of \$1.00 per value common stock which shall be designated as "Common Shares."

ARTICLE V.

In the event of any voluntary or involuntary liquidation, dissolution or winding up of this Corporation the assets of the Corporation shall be payable to and distributed ratably among the holders of record of the Common Shares.

ARTICLE VI.
VOTING RIGHTS

Except as otherwise provided by Law, the entire voting power for the election of Directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE VII.
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLES OF INCORPORATION OF

Pursuant to the provisions of §607.1005 of the Florida Business Corporation Act (the "Act"), South Florida Kinetics, Inc. (the "Corporation") adopts this Amendment to the Articles of Incorporation as set forth below:

1. The name of the Corporation is South Florida Kinetics, Inc..
2. The following amendments to the Corporation's Articles of Incorporation were adopted by the sole director of the Corporation on the 12th day of June, 1995, no shares yet having been issued, in accordance with and in a manner prescribed by §607.1005 and §607.1006 of the Act:

A. Articles I and VII are hereby amended in their entirety to read:

ARTICLE I - NAME

The name of the Corporation shall be SFK, Inc.

ARTICLE VII - AFFILIATED TRANSACTIONS

The Corporation, pursuant to Section 607.0901(5)(c) of the Florida Business Corporation Act expressly elects not to be governed by the provisions of Section 607.0901 thereof.
