# ARTICLES OF INCORPORATION OF CHI T. NGUYEN, P.A.

The undersigned subscriber to these Articles of Incorporation, natural people competent to contract and legally authorized to practice the profession of Deutistry in the State of Florida, hereby proceed to form a professional corporation in accordance with the Florida Professional Service Corporation Act and the Florida Business Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation.

### ARTICLE I. NAME

The name of the corporation established as a Florida Professional Association is: Chi T. Nguyen, P.A.

#### ARTICLE II. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business is as follows:
