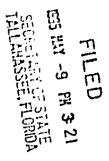

ARTICLES OF INCORPORATION

ARTICLE L .- NAME

The name of the corporation is RDJ INDUSTRIES, INC.

ARTICLE IL -- DUBATION

This corporation shall exist perpetually, commencing at the time of filling these Articles with the Secretary of State of the State of Florida.

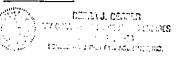

ARTICLE XL -- CALLING OF SPECIAL MEETINGS

Special meetings of Shareholders may be called by the Board of Directors of this Corporation.
