The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. The name of the corporations is: FUSKIE ENTERPRISES, INC. with the principal place of business being: 502 East New Haven Avenue, Melbourne, Florida 32901.

ARTICLE II. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
