

ARTICLES OF INCORPORATION
of
CROSSROADS PATIO FURNITURE REPAIR, INC.

ARTICLE I - Name

The name of the corporation is:



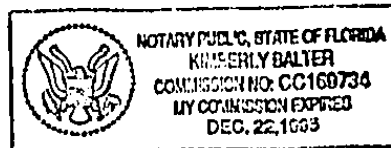


