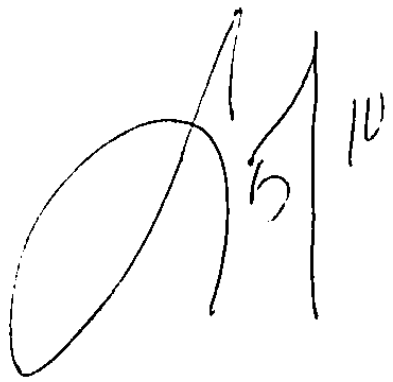

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is AILERON ASSOCIATES, INC., and its principal office or mailing address is 1255 Brightwaters Boulevard, St. Petersburg, FL 33704.
