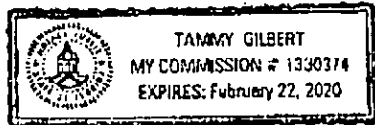
1. Article I of the Articles of Incorporation of FISHER FOOD CORPORATION is hereby amended to read as follows:


"ARTICLE I CORPORATION NAME

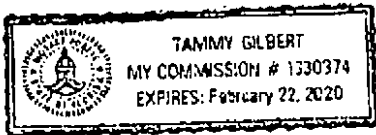
