ARTICLES OF INCORPORATION OF

A.C.R. EQUIPMENT AND SYSTEMS, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be A.C.R. Equipment and Systems, Inc.
