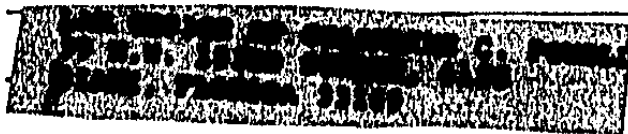


Please find the Articles of Incorporation for Webisco International Enterprises, Inc.

ARTICLE OF INCORPORATION
OF

WEBISCO INTERNATIONAL ENTERPRISES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation shall be known as **WEBISCO INTERNATIONAL ENTERPRISES, INC.** and shall conduct its corporate business at 6565 S.W. 41 PLACE, DAVIE, FLORIDA 33314.

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE

This corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of manufacturing and distribution of products and all other legal business.

ARTICLE IV

CAPITAL STOCK

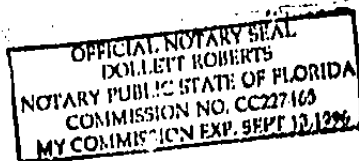


