Articles of Incorporation of LAURA MAY, INC

ARTICLE 1 - Name of corporation:

The name of this corporation is:

LAURA MAY, INC

ARTICLE II - Duration:

This corporation shall have perpetual existence commencing on the date of this filling of those Articles with the Department of State.

ARTICLE III - Purpose:

This corporation is organized for the purpose of transacting of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes as same now exists or may hereafter be amended.

ARTICLE IV - Capital Stock:

This corporation is authorized to issue 100 shares of One Dollar (\$ 1.00) par value common stock which shall be designated as " Common Shares".
