### **ARTICLE 1 - Name of corporation:**

The name of this corporation is:

#### **ARTICLE II - Duration:**

This corporation shall have perpetual existence commencing on the date of this filing of those Articles with the Department of State,

### **ARTICLE III - Purpose:**

# **ARTICLE IV - Capital Stock:**
