The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

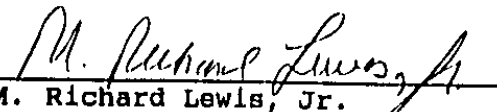
ARTICLE VII-BYLAWS

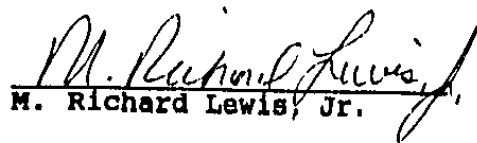

A. The name of this Corporation is Go Go Fuels, Inc.

B. An amendment to Article I of the Articles of Incorporation has been adopted by the sole shareholder of the Corporation, pursuant to Section 607.1003, Florida Statutes (1993), to change the name of this Corporation to Island Food Stores of Panama City, Inc. Article I now reads:

"ARTICLE I

The name of this Corporation is Island Food Stores of Panama City, Inc."

C. The date of the adoption of the amendment to Article I by the sole shareholder of the Corporation is May 25, 1995.

D. The holders of common stock of this Corporation were entitled to vote on this amendment, and the number of votes cast for the amendment was sufficient for approval by the holders of common stock.
