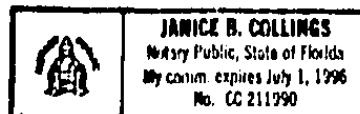




**CERTIFICATE OF DESIGNATION
