The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be as follows:

**M.I.C. PAVEMENT MARKING, INC.**

The principal place of business of this corporation shall be 6439 51st Avenue, Vero Beach, Florida 32967, and the mailing address shall be the same,

**ARTICLE II. NATURE OF BUSINESS**

This corporation shall engage or transact in any and all lawful activities or business permitted under the laws of the United States; of the State of Florida; or of any other state, country, territory, or principality.

**ARTICLE III. CAPITAL STOCK**
