OF

VICTOR A. SKINNER acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for SKINNER D.D.S., INC.

ARTICLE I
(Name)

(Duration)

The period of its duration is perpetual.

ARTICLE III
(Nature of Business)

The purpose of this Corporation is to transact in any and all lawful activities and businesses permitted under the laws of the state of Florida, the United States of America or any other state, country, territory or nation.

ARTICLE IV
(Capital Structure)

The aggregate number of shares which the Corporation shall have authority to issue is 1000, having a par value of \$1.00 per share.
