ARTICLES OF INCORPORATION
of

ARTICLE I - NAME

The name of the corporation is - - - MAGIC SEAL COATING & STRIPING INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the following purposes:
