ARTICLES OF INCORPORATION  
OF  
LIZ PRINTING, INC.

ARTICLE I  
CORPORATE NAME

The name of this corporation is LIZ PRINTING, INC.

ARTICLE II

INITIAL PRINCIPAL PLACE OF BUSINESS

The corporation's initial principal place of business shall be 1649 Forum Place, Suite 10, West Palm Beach, Florida 33401.

ARTICLE III  
NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

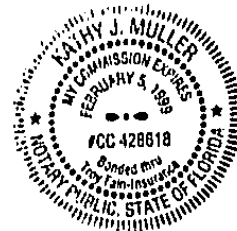
