# ARTICLE I

The name of this corporation is: BarDan Corp. and the principal office address is 1700 N. Dixie Highway, #100, Boca Raton, FL 33432.

#### ARTICLE II PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE III CAPITAL STOCK


