The undersigned subscribers to these Articles of Incorporation, each being a natural person competent to contract, hereby subscribe to and form a corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this corporation is Nations Abstract and Search, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office of the Corporation, or the mailing address of the Corporation if the principal office is not yet known, is 2640 Golden Gate Parkway, Suite 108, Naples, Florida 33942.

ARTICLE III

DURATION

The corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.

ARTICLE IV

PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V

NUMBER AND CLASS OF STOCK

The corporation is authorized to issue one class of stock which shall consist of 1000 shares of \$1.00 par value common stock, and which shall be designated "common shares".

ARTICLE VI

PREEMPTIVE RIGHTS

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.


ARTICLE XII


