



**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation, pursuant to the corporate laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I NAME

INTERNATIONAL PERSPECTIVES, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III STATEMENT OF PURPOSE


