THE UNDERSIGNED does hereby subscribe to, acknowledge and file the following Articles of Incorporation, for the purpose of operating a Corporation under the Laws of the State of Florida.

ARTICLE I - NAME

The Name of this Corporation is SHUCKUMS RAWBAR, INC..

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any and all bustness lawful and permitted under the laws of the State of Florida.
