# **ARTICLES OF INCORPORATION**

The Undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

## **ARTICLE 1.0 NAME AND ADDRESS**

The name of the Corporation is: D.M.P. Trading, Inc. The principal office and mailing address is 4171 Old Jennings Road, Middleburg, Florida, 32068.

## **ARTICLE 2.0 DURATION**

The duration of the Corporation is perpetual.

## **ARTICLE 3.0 PURPOSE**

The general purpose for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

## **ARTICLE 4.0 SHARES**

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1,000) shares of common stock. Such shares shall be of a single class and shall have a par value of \$.01/100 per share.

## **ARTICLE 5.0 INITIAL REGISTERED OFFICE AND AGENT**

The street and mailing address of the initial registered office of the Corporation is 6271 St. Augustine Road, Jacksonville, Florida, 32217, and the name of the initial registered agent at that address is Daniel J. Sullivan.

#### **ARTICLE 6.0 DIRECTORS**

The number of Directors constituting the Initial Board of Directors is one (3) . The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. 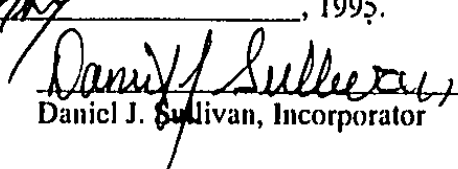
