ARTICLES OF INCORPORATION

ARTICLE I

NAME

The name of the corporation is LENGA & LAMOTHE, CORP.

ARTICLE II

PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the General Corporation Act of the State of Florida.

ARTICLE III

COMMENCEMENT


