ARTICLES OF INCORPORATION
OF

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following.

ARTICLE I.

The name of this corporation is:

PINSETTERS OF FLORIDA, INC.

The principal place of business of this corporation shall be 6926 Alpert Drive, Orlando, Florida 32810, and the mailing address shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to sponsor youth bowlers, contribute to public education, and to make charitable contributions.

ARTICLE III.

The membership of this corporation shall constitute all persons hereinafter named as officers and directors and such other persons who from time to time may become members by a majority vote and according to the bylaws.


