

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name and principal address of the corporation shall be D.D. HOFFMAN, INC., 8475 Cherish Dr., Sebastian, Florida 32976.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE: The purpose of the corporation is to transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

D.D. HOFFMAN, INC. also may own, buy, and sell parts of other businesses, real estate, and investments; conduct research; develop equipment; design, construct, own, sell, and lease equipment, and hold patents.

D.D. HOFFMAN, INC. may do writing of all types, including printing, publishing, distributing, buying, and selling; and take advantage of any and all opportunities, ventures, and spin-off that are legally available.

ARTICLE FOUR: CAPITAL STOCK: The aggregate number of shares which the corporation has authority to issue is one hundred (100) shares, all of which shall be common shares with a par value of (NONE) no par value.

ARTICLE FIVE: REGISTERED OFFICE & AGENT: The street address of the initial Registered Office of the corporation and name is:
