# ARTICLES OF INCORPORATION

OF

#### K.A.T. FUTURE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

# **ARTICLE 1**

#### NAME

The name of the corporation is **K.A.T. FUTURE**, **INC.** The principal place of business of the corporation shall be, or such other place as may be designated by the Board of Directors.
