The undersigned subscriber to these articles of incorporation being duly licensed to practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

**ARTICLE I  
NAME**

The name of the professional service corporation is Pamela J. Reynolds, P.A.

**ARTICLE II  
PRINCIPAL OFFICE**

The principal office and mailing address of this corporation is 1500 San Remo Avenue, Suite 220, Coral Gables, Florida 33146.

**ARTICLE III  
PURPOSE**

The professional service corporation is formed to engage in every phase and aspect of the practice of law. 
