ARTICLES OF INCORPORATION OF UNCLE JONES BAR-B-OUE, INC.

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be: UNCLE JONES BARES

ARTICLE II - DURATION OF EXISTENCE

The period of its duration is perpetual.

ARTICLE III - COMMENCEMENT OF CORPORATE EXISTENCE

The commencement of corporate existence shall be upon the filing of these Articles of Incorporation with the Secretary of State, State of Florida.

ARTICLE IV - GENERAL PURPOSE

The purpose of the corporation is to engage in any activities or lawful business permitted for corporations under both the laws of the United States of America and the State of Florida.

ARTICLE V - CAPITAL STOCK
