AMENDMENTS TO ARTICLES AND BY-LAWS

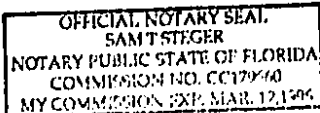
The power to adopt, amend, alter or repeal these Articles of Incorporation as well as the by-laws of this corporation shall be reserved to the shareholders.
