ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the Taws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is QUE VIDA PRODUCTIONS , INC ARTICLE II - NATURE OF BUSINESS
