I, the undersigned, for the purposes of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be:

TERM OF EXISTENCE

This Corporation shall exist perpetually or until dissolved by due process of law.

PURPOSE

CAPITAL STOCK

"This Corporation is authorized to issue par value common stock as described below, and none other:
