The following shall constitute the Articles of Incorporation organizing a corporation under the laws of the State of Florida.

#### ARTICLE ONE

The name of the corporation is:

INVERSIONES EL ELEGIDO, INC..

#### ARTICLE TWO

The duration of this corporation is perpetual. The corporate existence of this corporation shall commence on the date these Articles of Incorporation are executed.

## ARTICLE THREE

The general purpose for which this corporation is initially organized is to engage in the business of buying, selling, leasing, managing or otherwise dealing in real estate and related commercial activities.

This corporation may also engage in the transaction of any or all lawful business for which corprations may be incorporated pursuant to Chapter 607, Florida Statutes.

#### ARTICLE EIGHT

No contract, act or transaction of the corporation in the absence of fraud, shall be affected or invalidated by the fact that a director or directors of the corporation is party or are parties to or interested in such contract, act or transaction, or in any way connected with such person or persons, firm or corporation. Each and every person who may become a director of the corporation is hereby relieved from any liability that might otherwise exist from thus contracting with the corporation for the benefit of himself or any firm, association or corporation in which he may be in any way interested. Any director of the corporation may vote upon any contract or other transaction between the corporation and any subsidiary or controlled company without regard to the fact that he also is a director of such subsidiary or controlled company.
