ARTICLE I - CORPORATE NAME:

The name of the corporation is Minh Phat, Inc.

ARTICLE II - NATURE OF DUSINESS AND POWERS:

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.
