ARTICLES OF INCORPORATION

OF

RoadWear II, Inc.



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is RoadWear II, Inc. and the mailing address of the corporation is Boca Commerce Center, 7634 N.W. Sixth Avenue, Boca Raton, Florida, 33487.

ARTICLE II

PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.

CAPITAL STOCK
