ARTICLES OF INCORPORATION

OR

JOHN SHEA, P.A.

The undersigned, for the purpose of forming a corporation under the Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

John Shea, P.A.

Article 2. Mailing Address. The mailing address of the Corporation is:

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Purpose. The purposes for which the Corporation is organized are to engage in the practice of law and any other related legal and professional services permitted by Florida law.

Article 7. Incorporator. The name and address of the Incorporator is as follows:




