The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice engineering under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, Florida Statutes, Chapter 621, and other laws of the State of Florida.

ARTICLE I

RESTRAINT ON ALIENATION OF SHARES
