ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is DBG DEVELOPMENT, INC.

ARTICLE II

The duration of the corporation shall be perpetual, and the date and time of the commencement of corporate existence shall be May 8, 1995.

ARTICLE III

The general purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of the State of Florida.

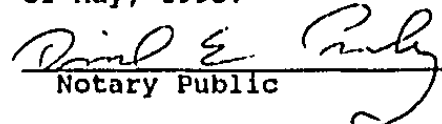

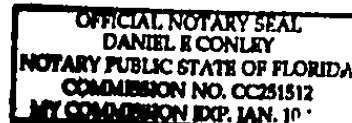
