ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Getra - General Trading Company and 4748 N.W. 103rd Court, Miami, Florida 33178, respectively.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock having a one cent (\$.01) par value per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
