

ARTICLE ONE - NAME

The name of the corporation is SSAR Corporation, Inc.

ARTICLE TWO - DURATION

This corporation shall have a perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE THREE - PURPOSE

This corporation is organized for the the purpose of transacting any and all lawful business or activities permitted under the Laws of the United States and Florida.

ARTICLE FOUR - CAPITAL STOCK

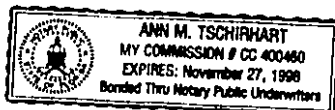
