ARTICLE I - Name

The name of this corporation is Suvi Investment Corp.

ARTICLE II - Principal Office

ARTICLE III - Purpose

This corporation is organized for the purpose of any and all business pursuant to the laws of the State of Florida.

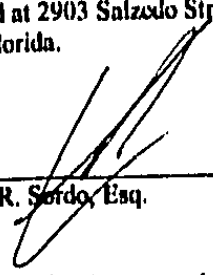
