

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be PLAY IT FIRST, INC.
