The undersigned, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of this corporation shall be **PLAY IT FIRST, INC.**

**ARTICLE II. COMMENCEMENT & DURATION**

The commencement of this corporation's existence shall be upon the filing of these Articles of Incorporation with the State of Florida Department of Corporations. This corporation's duration shall be perpetual.

**ARTICLE III. PURPOSE**

The corporation is organized for the purpose of electronic game sales and for transacting any and all lawful business allowed by the United States of America.

**ARTICLE IV.**

**CAPITAL STOCK**

This corporation is authorized to issue one hundred (100) shares of \$1.00 par value common stock.

**ARTICLE V.**

Unless otherwise provided for in the corporation's bylaws, a minimum of 75% of all shares entitled to vote, represented in person or by proxy, shall be required to constitute a quorum at a meeting of shareholders.

#### **ARTICLE X. BYLAWS**


Corporate Bylaws will be hereinafter adopted by the Board of Directors. The corporate Bylaws may be amended or repealed, in whole or in part, by the Board of


